Curtis Memorial Hospital, using a combination of in-person and virtual telehealth service options.

- ✓ Proof of registration with the Newfoundland and Labrador Council of Health Professionals;
- ✓ Strong interpersonal and organization skills and current knowledge of professional practice issues and standards are essential;
